It is pertinent to mentioned here that Tenders forms will be sold only to eligible firms having enclosed attested photo sate copy of CST/VAT registration No. or TIN;

PAN CARD, Trading license etc with application.

2. Sealed Tenders duly completed are invited up to 16<sup>th</sup> August, 2011 at 1030 hrs and will be opened at 1100 hrs. On the same day, and will be finalized on 18<sup>th</sup> August, 2011. In case, said date is declared holiday under Negotiable Act, the tenders will be opened on next working day at same time and venue, however date and time for submission of tenders remains the same.

3. The earnest money of successful tenders will be adjusted towards the security on the request of tenders. The earnest money of unsuccessful tenders will be refunded. No interest will be paid on earnest money.
