- 2) The particulars of the provisionally called candidates for interview are shown in Annexure “A” of this notification.

- 3) As already notified the criteria for the above said posts is reproduced hereinbelow :-

DRAFTSMAN

- i) Two years certificate of Draftsmanship in Civil = 70 points (on prorata basis)
ii) Viva Voce = 30 points
TOTAL = 100 points

MEDICAL ASSISTANT

- i) Matric = 20 points (On prorata basis)
ii) Diploma in Medical Asst Training course from SMF or any other recognized institute = 60 points (on prorata basis)
iii) Viva Voce = 20 points
TOTAL = 100 points

- 4) ***Only those candidates shall be allowed to appear in the interview, who fully conform to the terms and conditions laid down in the advertisement notices; and have migrated from Kashmir Valley after 1st of November 1989 and is registered as such with the Relief Commissioner or has not been so registered on the ground of his being in service of Government in any moving office, or having left the Valley or any other part of the State in pursuit of occupation or vocation or otherwise, and is possessed of immovable property at the place from where he has migrated but is unable to ordinarily reside there due to the disturbed conditions and includes an internally displaced person; For the purpose of this clause an internally displaced person means a person who had to migrate within valley from his original place of residence in Kashmir Valley for reasons of security and is registered as such with the Relief and Rehabilitation Commissioner Migrants; “ In order to ensure that only bonafide migrants are interviewed by the Board, the candidates are required to produce the Migrant Certificate / Internally Displaced Certificate issued by the Relief and Rehabilitation Commissioner J&K, as per the approved format as a proof.”***

- 5) The particulars of the candidates whose candidature has not been considered on the ground that their Application forms are found devoid of rules/ terms and conditions of the advertisement notification are shown in Annexure “B” of this notification. No separate intimation shall be communicated further in this behalf.

- 6) **It should be noted that no supplementary list shall be issued for the purpose of the interview. Any applicant having any sort of grievance are advised to submit their claim alongwith all relevant testimonials self attested and duly attested by Gazetted Officer to the Central Office of the Board within one week from the date of publication of this notification and thereafter no claim shall be entertained whatsoever may be the reasons or grounds.**

- 7) The candidates shall be allowed to appear in the interview only subject to the possession of prescribed qualifications within cut off dates as mentioned in the advertisement notice.

- 10) **Mere figuring of name in the provisional shortlist does not entitle the candidate to appear in the interview as it shall be subject to the detailed scrutiny of all testimonials / certificates of the candidates called for interview.**
- 11) In case of any deficiency with reference to eligibility etc proved at the time of **interview**, the candidate shall not be allowed to appear in the **interview** or if deficiency is found subsequently the candidate shall not be considered for selection and will be treated as disqualified.
- 12) The candidate shall have to produce all original as well as attested photocopies of certificates / testimonials including **Migration certificate** in the prescribed format as asked for vide above referred advertisement notification before the selection committee at the time of interview.
