NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution, the Governor hereby makes the rules regulating the method of recruitment to the post of Watcher (Male) as in the Schedule annexed hereto under Education (Social Welfare and Social Education) Department, namely :-

1. Short title and commencement --
 - i) These rules may be called "Recruitment Rules" for the post of Watcher (Male) under Education, (Social Welfare & Social Education) Department.
 - ii) They shall come into force on the date of their publication in the Official Gazette.
2. The name of the post is specified in Column-I of the schedule annexed hereto.
3. Number, Classification and Scale of pay :-
The number of the said post, its classification and the scale of pay are as specified in columns 2 to 4 of the schedule annexed hereto.
4. Method of recruitment, Age limit, Qualification, etc :- The method of recruitment to the said post, age limits, qualifications and other matters relating to the said post are as specified in columns 5 to 13 of the said schedule.
5. Disqualification :-
No person :-
 - (a) Who has entered into or contracted a marriage with a person having spouse living, or
 - (b) Who, having a spouse living has entered into or contracted a marriage with any persons shall be eligible for appointment to the said post.

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and that there are other grounds for so doing, exempt any persons from the operation of these rules.
6. Power to relax :- Where the State Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in the writing, and in consultation with the Tripura Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
7. Saving :- Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Schedule Castes, the Schedule Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.

RECRUITMENT RULES FOR THE POST OF WATCHER (MALE) UNDER EDUCATION DEPARTMENT (SOCIAL WELFARE AND SOCIAL EDUCATION) GOVT. OF TRIPURA.

1. Name of the post(s) :- Watcher (Male)
2. Number of post(s) :- 7(seven)
3. Classification :- Group- 'C' (Non-Gazetted).
4. Method of recruitment whether by direct recruits or by promotion or by deputation/transfer and percentage of the vacancies to be filled by various methods. :- 100% by direct recruitment from male candidate.
5. Scale of pay :- Rs. 3200-90-4280-100-5480-110-6030/-
6. Age limit for direct recruitment :- Eligibility :
20 to 25 years. Upper age limit relaxable by 5(five) years in case of SC/ST/Ex-Sr. Govt. servant candidates.
7. Educational & Other qualification required for direct recruitment. :-
 1. Minimum educational qualification :-
 - (i) Matriculation/(Class-X passed) or equivalent for General.
 - (ii) Class-VIII passed for SC/ST.
 - (iii) Arms training, proficiency in sports, PT, drill and Knowledge of useful handicrafts will be additional qualification.
 2. Minimum physical fitness. :-
 - (a) Height for ST candidate=165 cm. For others 167.64 cm.
 - (b) Chest 78.74 cm. (unexpanded) and 83.82 cm. (expanded) for those whose height is 167.64 cm. or more and 76.2 cm. (Unexpanded) and 81.28 cm. (expanded) whose height is less then 167.64 cm.
8. Whether age and educational qualifications prescribed for the direct recruitment will apply in case of promotees. :- Not applicable.
9. Whether Selection post or Non-selection post. :- Non-Selection.
10. Period of probation, If any. :- 2(two) years.
11. In case of recruitment by promotion/deputation/transfer, grade from which promotion/deputation/transfer is to be made. :- Not applicable.
12. If a D.P.C. exists, what is its composition. :- Not applicable.
13. Circumstances in which T.P.S.C. is to be consulted in making recruitment. :- Not applicable.
