NOTIFICATION

The 17th November, 2009

No. TPT (B)-84/2009- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in super session of the Government of Arunachal Pradesh, State Transport Department Recruitment Rules to the post of Assistant Station Superintendent, 1987 except as respect things done or omitted to be done, the Governor or Arunachal Pradesh hereby makes the following Rules to regulate the method of recruitment to the post (s) of Assistant Station Superintendent, under the Department of Transport, Government of Arunachal Pradesh, namely:-

1. Short title and commencement: (i) These Rules may be called “The Arunachal Pradesh Assistant Station Superintendent, Group-‘B’ (Gazetted), Recruitment Rules, 2009”.

(ii) They shall come into force from the date of their publication in the Official Gazette.

2. Number of posts, classification and Pay Band/Grade Pay/Pay Scales: The number of posts, their publication and the Pay/Band/Grade Pay/Pay Scales attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these Rules.

3. Method of recruitment, age limit and qualification etc.: The method of recruitment, age limit, qualification and other matter relating thereto shall be as specified in columns 5 to 14 of the said schedule.

4. Disqualification: No person,-

(i) Who has entered into or contracted a marriage with a person having a spouse living; or

(ii) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post:

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for doing so, exempt any person from the operation of these rules.

5. Power to relax: Where the Governor of Arunachal Pradesh is of the opinion that it is necessary or expedient to do so, he may, by order for reasons to be recorded in writing and in consultation with the Selection Board/Arunachal Pradesh Public Service Commission, relax any of the provisions of these rules with respect to any class or category of person.

6. Repeal: All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have validly made or taken under the corresponding provisions of these rules.

7. Savings: Nothing in these rules shall affect reservation /relaxation of age limit and other concessions required to provide for the Scheduled Castes and Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.
